New York State Sales Tax Increase

On December 1, 2007, the Clinton County sales and use tax increased to 4.0% from 3.75%. The Champlain Telephone Company (PrimeLink) did not receive notification of the tax rate increase in time to apply the new rate to your December 2007 bill. The new rate has been applied to your January 2008 bill. Additionally, in January, you will find a separate charge for December's uncollected sales tax.

Another major event that happened this past Fall in the Vocal Music Department took place when the N.C.C.S. Acoustifellas and Kaliedosaic members were invited back to the WCFE Mountain Lake PBS station to be recorded as part of WCFE's "Holiday Spectacular" show. Both groups performed the song "Dashing Through the Snow" combined with their own creative twist.

This is the group's second year to be asked to perform as part of this project. When asked how things went upon their return to N.C.C.S., one member of the group said "It has never been this easy; only four or five takes!"
